2.When to register? Regular Registration Period

11th December 2024 – 20th December 2024

If you miss the deadline;

Late Registration Period	Total Payment
21 st December 2024 - 31 st December 2024	Fee + 10% of the Fee Ex: (Rs. 150,000 + Rs. 15,000) = Rs. 165,000

** Any delay in processing must be informed to Academic Affairs Division during the regular registration period. Failing which, the student will be charged with late processing fee.

Notes

1. “Failed modules” mentioned here includes both “repeat modules” and “incomplete modules”.
 2. This is applicable to all the programs unless otherwise specified.
- The Head of department at their discretion may decide to allow students to proceed to the next year ONLY under the condition that they may take a maximum of **3 modules** (prorata or repeat in total) in addition to the normal semester workload.
 - Those who are not allowed to proceed to the next level will be eligible for a full refund and their registration will be cancelled (if already registered).
